**HENRY G. OVERMAN, London School of Economics**

*The Future of British Cities and the Role of Urban Policy*

We are delighted to welcome Henry G. Overman, Professor of Economic Geography at the London School of Economics and Director of the What Works Centre for Local Economic Growth to discuss the subject of the future of British Cities and urban policy.

Formerly Director of the Spatial Economics Research Centre, Henry's current research interests include the causes and consequences of spatial disparities, and the impact of urban and regional policy. His research has been published in leading economics journals, and he has provided policy advice to numerous Government departments and the European Commission.

Henry was awarded the August Loesch Prize in 2006 and the Geoffrey J D Hewings Award in 2009 for outstanding research and distinguished contributions to Regional Science.

## **MEMBERSHIP RENEWAL**

The SBE's thriving and diverse membership network is one of its key assets, with members enjoying a full calendar of meetings and master classes. ## **NEW! SBE AFFILIATE**

As members will know, membership of the Society is restricted to individuals with a professional interest in business economics and who apply their knowledge in the context of their work, or to students studying for a relevant degree. There are, therefore, a large number of people who have an interest in business economics but are unable to take part in events or support the Society. We are therefore going to launch, from July, a new SBE Affiliate status open to individuals who do not meet the Society's membership standards; acceptance as an SBE Affiliate will be at the Council's discretion.

Affiliate status will not be a new membership category. SBE Affiliates will not have voting rights or access to the Society's membership list, and Affiliate fees will not (unlike membership subscriptions) be tax deductible. SBE Affiliates will, however, have access to meetings, events and masterclasses; and the extension of the Society's reach in this way will, we hope, be of considerable benefit to members' own networks.

The fee for SBE Affiliate status will be £120 for the year beginning July 2014, so if you have colleagues who may be interested, do tell them the good news. Details will be on the SBE website shortly, and the Secretariat will be happy to help with questions or applications in the meantime.
